Amenities & Events

Gym - The Clubhouse gym is open daily from 5:00 AM until 11:00 PM. To access the gym, you will need to purchase a gym key fob for a refundable deposit of \$20 each (check/money order only). Please visit the Lifestyle Office to receive your gym key fob. Applications may be accessed on the HOA website. Fitness classes are offered in the Clubhouse Fitness Room. Please view the <u>Events Calendar</u> online to see the latest fitness schedule and details. No need to register but it is recommended to arrive 15 minutes early for fitness classes.

Pool - The LVII pool is typically open Memorial Day weekend through Labor Day weekend. To access the pool, you will need to purchase a pool pass for \$10 (check/money order only). Each resident, age 4 and up, will need their own pass. Please visit the Lifestyle Office to receive your pool pass. Applications and pool rules can be accessed on the HOA website.

Events/Activities - The LVII HOA hosts numerous events each month, including kids' classes/camps, fitness programs, 21+ parties, social clubs, and much more! Annual events include the Mardi Gras Party, Easter Egg Hunt, Memorial Day BBQ, Halloween Spooktactular, and Santa Visit among others. View the event calendar on the HOA website and subscribe to the weekly e-blast for event/activity details.

Architectural Modification - Architectural Applications are required for any exterior modifications to your home. Applications and guidelines can be found on the HOA website.

Architectural Review Committee (ARC) meetings are generally held at 9:00 AM on the first Tuesday of each month, in the Clubhouse. Meetings are open for residents to attend. Applications are due one week prior to each meeting. Please see the HOA website for possible changes to the ARC meeting schedule.

Clubhouse Rentals - The Loudoun Valley II Clubhouse is available for rent to homeowners in good standing. Please check the rental calendar online for availability before contacting the Lifestyle Office at 703.726.6205 for booking. Only one rental is permitted per day. The rental agreement listing the rental rates is available on the HOA website. The agreement must be completed and returned, along with the rental and security deposit checks **two weeks** before the date can be reserved.
